

Jeff Wagner's How Much Do You Love Golf?

OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCE OF WINNING.

Starting on Monday, February 10, 2020 and ending on Friday, February 14, 2020, on Newsradio 620 WTMJ Jeff Wagner's Show (12pm-3pm CST), fans will have the chance to win a grand prize of a \$25 gift card to Six Golf. Fans can qualify to win the prize by commenting what they love most about golf on the daily Stix Golf Valentine post on the official WTMJ Facebook page. The WTMJ Facebook page will post a new Stix Golf Valentine each weekday at 8am CST which fans must comment on by 1:30pm CST in order to be eligible. Before 3pm CST on each weekday of the promotion, host/Jeff Wagner will pick one of the comments to win the grand prize. It is up to the discretion of the host/Jeff Wagner if a fan's comment is the best comment of that corresponding day's post to win the grand prize. Fans may comment once each day of the promotion but may only win once. There will be a total of (5) grand prize winners by the end of the promotion.

1. HOW TO ENTER

- a. These rules govern the How Much Do You Love Golf? promotion (the "Promotion") being conducted by Newsradio 620 WTMJ, 720 E Capitol Drive, Milwaukee, WI 53212 ("GKB") beginning on Monday, February 10, 2020 at 8am CST and ending on Friday, February 14, 2020 at 3pm CST.
- b. To participate in the Promotion, you may enter via the following method(s):
 - Comment on the daily Stix Golf Valentine Facebook post on the WTMJ page by 1:30pm CST what you love most about golf. Before 3pm CST on each weekday of the promotion, the host/Jeff Wagner will pick (1) of the comments to win the grand prize. Winner will be announced on Jeff Wagner before 3pm CST each weekday of the promotion.
- i. To participate in the Promotion, you must visit and like the official WTMJ Facebook page at <https://www.facebook.com/620wtmj> ("Page"). You must have a valid Facebook account in order to enter. If you do not already have one, you can create a Facebook account at no cost by visiting <http://www.facebook.com>. Limit one (1) entry per eligible person per day during the Entry Period regardless if entrant has more than one email address or Facebook account. Multiple participants are not permitted to share the same email address or Facebook. Participants wanting to enter the contest must also comment on the daily Stix Golf Valentine post by 1:30pm CST on the above official WTMJ Facebook page explaining why they love golf in order to be eligible to win the grand prize. The WTMJ Facebook page will post a new Stix Golf Valentine each weekday at 8am CST for the contest. Eligible comments will then be reviewed by the host/Jeff Wagner and

considered for the grand prize. The grand prize winners will then be announced before 3pm CST each day of the promotion and contacted by the marketing team through Facebook with further instructions on picking up their prize. Entries submitted may not be acknowledged or returned. Proof of submission of an entry shall not be deemed proof of receipt by GKB. Internet entrants are subject to all notices posted online including but not limited to GKB's Privacy Policy. Use of Facebook as a means of entry will be subject to Facebook's privacy policy and terms of service. By participating in the Promotion, entrant understands that he or she is providing his or her information to GKB and not Facebook. Further, entrant specifically agrees to release Facebook from any and all liability associated with this Promotion. The Promotion is in no way sponsored, endorsed or administered by, or associated with, Facebook.

- c. (1) entry is allowed per Facebook per day account for this contest.

Show times are subject to change based on breaking news and specialty content at the discretion of GKB. GKB has the right to notify fans and to not update contest rules or the webpage when such situations occur.

2. ELIGIBILITY RESTRICTIONS

- a. The Promotion is open to all persons who are 18 and who reside in Wisconsin. Employees of GKB, its subsidiary and affiliated entities, GKB's advertising and promotional agencies, its participating sponsors, Milwaukee metropolitan area and the members of their immediate families (spouse, parents, siblings, or children) and/or households (whether related or not) are ineligible to participate or win. This Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited.
- b. Listeners are eligible to win a prize in a Promotion conducted by GKB only once every seven (7) days and only once every thirty (30) days if the prize is valued over \$600. Only one (1) winner per household is permitted in any GKB promotion.

The winner will forfeit any prize or prize certificate not claimed within forty-five (45) days of winning. In the event that a prize or prize certificate is mailed to the winner, it will be with the prior written consent of the winner and therefore, winner assumes the risk of its loss. GKB is not responsible for the safe arrival of a prize or prize certificate.
- b. There is no substitution, transfer or cash equivalent for prizes, except that GKB may, at its sole discretion, substitute prizes or cash of comparable value. The prizes are expressly limited to the item(s) listed above and unless otherwise expressly specified, do not include taxes, gratuities or any other expenses. Other restrictions may apply.

4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of GKB management with respect to the Promotion are final.
- b. (1) winner will be selected each weekday starting on Monday, February 10, 2020 at 8am CST through Friday, February 14, 2020 at 3pm CST for (5) winners total. Winner will be decided at the discretion of Jeff Wagner/host and the producer on that day's show.
- c. All final winners will be determined by Friday, February 14, 2020 at 3pm CST.
- d. Odds of winning a grand prize is up to the discretion of the host/Jeff Wagner. Each Facebook comment will be judged by Jeff Wagner/host on the quality of their comment about why they love golf in order to win the grand prize, awarded by Jeff Wagner/host.
- e. Qualifiers and the Grand Prize winner need not be present to win.
- f. The winner must execute and return any required affidavit of eligibility and/or liability/publicity release within ten (10) days of winning or prize will be forfeited. If a potential winner cannot be contacted, fails to sign and return the required affidavit of eligibility and/or liability/publicity release within the required time period, or if a prize or prize notification is returned as undeliverable, the potential winner forfeits the prize.

5. CONDITIONS

- a. Payments of all federal, state and local taxes are solely the responsibility of the winner. The winner will be required to complete and submit an IRS Form W-9 with the winner's full Social Security Number or the equivalent for receipt of any

- e. GKB, in its sole discretion, reserves the right to disqualify any person tampering with the entry process or the operation of GKB's website.
