

2024 STATE FAIR BREWER TICKET GIVEAWAY

OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCE OF WINNING.

620 WTMJ and the Brewers Radio Network is giving away one (1) 4-pack of tickets to see the Milwaukee Brewers play the St. Louis Cardinals on Tuesday, September 3, 2024, at American Family Field at 1:10PM CST. Fans may enter by landing on the designated spot on the prize wheel at the 620 WTMJ street team at Wisconsin State Fair on days Wisconsin State Fair takes place between Thursday, August 1, 2024, and Sunday, August 11, 2024. Fans must make three out of three shots, scan the QR posted at the 620 WTMJ Wisconsin State Fair Street Team and complete the online form to enter to win the tickets. A winner will randomly be selected from the entries after the completion of the Wisconsin State Fair festival. ARV of the prize is \$200.

1. HOW TO ENTER

- a. These rules govern the 2024 Wisconsin State Fair Brewer Ticket Giveaway promotion (the "Promotion") being conducted by 620 WTMJ Radio 301 W Wisconsin Ave, Suite 200, Milwaukee, WI 53203 ("GKB") beginning on Thursday, August 1, 2024, at 12PM CST and ending on Sunday, August 11, 2024, at 4PM CST.
- b. To participate in the Promotion, you may enter via the following method(s):
 - i. Fans must spin the prize wheel at the WTMJ on-site activation and land on the designated spot for entry to win Brewers Tickets. Upon landing on the spot, fans must scan the QR code on site and complete the entry form to be entered into a pool for random drawing
- c. To participate in the Promotion, you may go to the Wisconsin State Fair at 640 S 84th St, West Allis, WI 53214 on days and times the festival takes place between Thursday, June 21, 2024, and Sunday, August 11, 2024. Fans must successfully land on a designated spot on a prize wheel and complete an official entry form (while supplies last) including first and last name, complete address, city, state, zip code, home telephone number and date of birth, and put the entry form in the registration box. All entries must be received by 4PM CST on Sunday, August 11, 2024. GKB is not responsible for lost, stolen, mangled, misdirected, postage due, illegible, incomplete or late entries.
 - ii. Show times are subject to change based on breaking news and specialty content at the discretion of GKB. GKB has the right to not notify fans and to not update contest rules or the webpage when such situations occur.

2. ELIGIBILITY RESTRICTIONS

- a. The Promotion is open to all persons who are 18 and who reside in Wisconsin. Employees of GKB, its subsidiary and affiliated entities, GKB's advertising and promotional agencies, its participating sponsors, and the members of their immediate families (spouse, parents, siblings, or children) and/or households (whether related or not) are ineligible to participate or win. This Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited.
- b. Listeners are eligible to win a prize in a Promotion conducted by GKB only once every seven (7) days and only once every thirty (30) days if the prize is valued over \$600. Only one (1) winner per household is permitted in any GKB promotion.
- c. The winner must provide valid government-issued photo identification and provide his or her complete address, date of birth and phone number to claim a prize.
- d. Entrants are required to provide truthful information and GKB will reject and delete any entry that it discovers to be false or fraudulent. GKB will disqualify any entry from individuals who do not meet the eligibility requirements.

3. PRIZES

- a. One (1) total prize will be awarded in this Promotion. The prize will consist of four (4) tickets to see the Milwaukee Brewers play the St. Louis Cardinals on Tuesday, September 3, 2024, at American Family Field at 1:10PM CST.

The Approximate Retail Value ("ARV") of the four (4) tickets is \$200. The winner will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the Prize. GKB accepts no responsibility for repairing any real or supposed damage to any prize.

- b. All prizes or prize certificates may be picked up at the office of GKB at the address below. The winner will forfeit any prize or prize certificate not claimed within forty-five (45) days of winning. In the event that a prize or prize certificate is mailed to the winner, it will be with the prior written consent of the winner and therefore, winner assumes the risk of its loss. GKB is not responsible for the safe arrival of a prize or prize certificate.
- c. There is no substitution, transfer or cash equivalent for prizes, except that GKB may, at its sole discretion, substitute prizes or cash of comparable value. The prizes are expressly limited to the item(s) listed above and unless otherwise expressly specified, do not include taxes, gratuities or any other expenses. Other restrictions may apply.

4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of GKB management with respect to the Promotion are final.

- b. One (1) grand prize winner will be selected by 11:59PM on Monday, August 12, 2024.
- c. The final winners will be determined by 11:59PM CST on August 12, 2024.
- d. Qualifiers must listen to 620WTMJ to win. Qualifiers and the Grand Prize winner need not be present to win.
- e. The winner must execute and return any required affidavit of eligibility and/or liability/publicity release within ten (10) days of winning or prize will be forfeited.

5. CONDITIONS

- a. Payments of all federal, state and local taxes are solely the responsibility of the winner. The winner will be required to complete and submit an IRS Form W-9 with the winner's full Social Security Number or the equivalent for receipt of any prize valued at \$600 or more or for any prizes awarded by GKB in a calendar year with an aggregate value of \$600 or more. Failure to submit a complete W-9 or equivalent will result in forfeiture of the prize. Such winnings of \$600 or more will be reported to the IRS.
- b. If the Promotion is terminated before the original end date, GKB reserves the right to select the winner(s) by random drawing from among all eligible non-suspect entries received as of the termination time/date or otherwise modify the procedure for selecting winner(s).

- e. GKB, in its sole discretion, reserves the right to disqualify any person tampering with the entry process or the operation of GKB's website. Failure to comply with the rules of the Promotion may result in a contestant's disqualification and/or forfeiture of any prize or prizes. If GKB makes a good faith determination that an entrant has cheated or committed fraudulent activity in connection with a Promotion, GKB reserves the right to disqualify that entrant from entering and/or winning future Promotions and to prosecute and seek damages to the fullest extent permitted by law.
