The undersigned law enforcement officer of the Fond du Lac Sheriff, being first duly sworn, states that:

**Count 1: BESTIALITY - ENGAGE IN SEXUAL CONTACT WITH ANIMAL (1ST OFFENSE)**

The above-named defendant on, about, or between January 1, 2020 and November 29, 2023, in the Village of Campbellsport, Fond du Lac County, Wisconsin, did knowingly engage in sexual contact with an animal, contrary to sec. 944.18(2)(a) and (3)(a), 939.50(3)(h) Wis. Stats., a Class H Felony, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than six (6) years, or both.

**Count 2: BESTIALITY - ENGAGE IN SEXUAL CONTACT WITH ANIMAL (1ST OFFENSE)**

The above-named defendant on, about, or between January 1, 2020 and November 29, 2023, in the Village of Campbellsport, Fond du Lac County, Wisconsin, did knowingly engage in sexual contact with an animal, contrary to sec. 944.18(2)(a) and (3)(a), 939.50(3)(h) Wis. Stats., a Class H Felony, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than six (6) years, or both.

**Count 3: BESTIALITY - ENGAGE IN SEXUAL CONTACT WITH ANIMAL (1ST OFFENSE)**

The above-named defendant on or about Wednesday, February 7, 2024, in the Village of Campbellsport, Fond du Lac County, Wisconsin, did knowingly engage in sexual contact with an animal, contrary to sec. 944.18(2)(a) and (3)(a), 939.50(3)(h) Wis. Stats., a Class H Felony, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than six (6) years, or both.

**Count 4: BESTIALITY - PHOTOGRAPH, FILM SEXUAL CONTACT WITH ANIMAL (1ST OFFENSE)**

The above-named defendant on or about Wednesday, February 7, 2024, in the Village of Campbellsport, Fond du Lac County, Wisconsin, did knowingly photograph or film obscene material depicting a person engaged in sexual contact with an animal, contrary to sec. 944.18(2)(e) and (3)(a), 939.50(3)(h) Wis. Stats., a Class H Felony, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than six (6) years, or both.

**Count 5: ATTEMPT BESTIALITY - DISTRIBUTE, SELL, PUBLISH SEXUAL CONTACT WITH ANIMAL MATERIAL (1ST OFFENSE)**

The above-named defendant on or about Wednesday, February 7, 2024, in the Village of Campbellsport, Fond du Lac County, Wisconsin, attempted to knowingly distribute, sell, publish, or transmit obscene material depicting a person engaged in sexual contact with an animal, contrary to sec. 944.18(2)(f) and (3)(a), 939.50(3)(h), 939.32 Wis. Stats., an attempt to commit a Class H Felony, and upon conviction may be fined not more than Five Thousand Dollars (\$5,000), or imprisoned not more than three (3) years, or both.

**PROBABLE CAUSE:**

Complainant bases this complaint upon the reports and investigation of Lt. Lichtensteiger of the West Bend Police Department and Det. Flood of the Fond du Lac County Sheriff's Office. Complainant, Lt. Lichtensteiger, and Det. Flood are all reliable as sworn law enforcement officials.

Complainant reports that Lt. Lichtensteiger reports that while investigating a different matter concerning Steven Rosales, the above named defendant, law enforcement learned that Steven sent text messages to Witness 1. Witness 1 provided her phone to law enforcement and consented to a search of the phone. Detective Goehring completed a Cellebrite extraction of Witness 1's phone on 4/10/24.

On 4/11/24, Lt. Lichtensteiger reviewed the contents of Witness 1's phone and noted several conversations between Witness 1 and Steven regarding Steven engaging in sexual intercourse and cunnilingus with his dog. The message format below lists whether the message was sent to or from Steven, the content of the message, and the date and time the message was sent or received by Witness 1. This is just an excerpt of some of the messages sent and received and does not represent the entire conversations between Witness 1 and Steven.

From: Steven

I've fucked my dog before. Female dog that is.

11/29/2023 12:23:06 PM(UTC-6)

To: Steven

How did you do that?

11/29/2023 12:23:58 PM(UTC-6)

From: Steven

I used lots of lube and laid her on her back, close to the edge of the bed. I know, but still a weird thing to hear. And it's illegal. I just don't want you thinking I'm a weirdo. I just want you to understand that's what happened when I have alone downtime.

11/29/2023 12:38:02 PM(UTC-6)

To: Steven

Do you still do it? Did it feel good? Did you like it? Did she like it?

11/29/2023 12:39:49 PM(UTC-6)

From: Steven

I haven't done it in a LONG time. It did feel good. Super tight. I liked it. I did cum obviously. Lol. I think she didn't mind it. Lol.

From: Steven

I'd rather be home jerking off, fucking my dog, and trying to get my male dog to fuck me.

From: Steven

Oh I forgot to tell you, I ate out my dog a little bit the other night.

From: Steven

I'd like to do both!!!! She was laying on the couch, so I just spread her open and started eating her out. She just laid there.

2/7/2024 8:43:27 PM(UTC-6)

To: Steven

How did you like it? Did you fuck her after?

2/7/2024 8:43:43 PM(UTC-6)

From: Steven

I loved it. She tasted sweet. And no, I didn't have enough time.

To: Steven

Is this the same dog you fucked in the past?

To: Steven

She tasted sweet, that's surprising....

2/7/2024 8:45:19 PM(UTC-6)

To: Steven

Did you at least jack off after you ate her?

2/7/2024 8:45:57 PM(UTC-6)

From: Steven

Yeah same dog. And yes I did jack off. Lol.

From: Steven

So if I show you me eating my dog, do I get to see you getting eaten eventually? 2/8/2024 6:24:59 PM(UTC-6)

From: Steven

Out of curiosity, why do you want to see me eat out my dog?

To: Steven

Idk!! You don't have to show it to me, I'm ok with that.

2/8/2024 6:31:44 PM(UTC-6)

From: Steven

I'm ok with it, I was just curious

From: Steven

She's actually laying on the couch next to me and I just want to spread her legs and taste

her sweet dog pussy.

From: Steven

I can't. DAMN IT! It was a picture of me eating out my dog last night.

2/10/2024 9:24:29 AM(UTC-6)

On 4/12/24, Lt. Lichtensteiger and Captain Grinwald spoke to Steven at his residence located on New Cassel St., Campbellsport, Fond du Lac County, Wisconsin. Steven said he has three dogs at his residence. Steven said all three dogs are Golden Retrievers, Tolula (4-years-old), Texas (2-years-old), and Tessa (1-year-old). Steven confirmed there were messages sent between him and Witness 1 about involving animals and sexual acts. Steven said he did this to try to get Witness 1 to be aroused by his actions.

Steven said he did recall telling Witness 1 that he "tasted" his dog. Steven said he did not recall how the topic came up between the two or when it occurred but he did recall telling her that he had done so. Steven said he knew Witness 1 told him she wanted to see a picture of him licking his dog's vagina. Steven said he did try to send a photo, but did not recall if it actually went through. Steven said Tolula was the dog that he took the photo with. Steven said he did take a photo by his dog's vagina, but he "was kind of down there, like not really doing anything a whole lot."

Steven said he deleted the photo in the messages. In the first investigation, Steven consented to a search of his cell phone. The photo that was taken and attempted to be sent was not located in that cell phone extraction.

Lt. Lichtensteiger asked Steven to further describe this interaction with Tolula. Steven said his face was down by Tolula's vagina and his tongue may have been out. Steven initially denied putting his tongue on or licking Tolula's vagina, but Lt. Lichtensteiger confronted him that his messages said otherwise. Steven said he told Witness 1 about the dog tasting sweet. Steven said he did not know what the dog tasted like. Lt. Lichtensteiger told Steven that Lt. Lichtensteiger did not believe him as he was the one driving the conversation with Witness 1 about sexual interactions with their dogs.

They revisited the topic of Steven engaging in oral sex with Tolula later in the conversation. Steven said his tongue was out when he was taking the picture and his tongue may have touched Tolula's vagina. Lt. Lichtensteiger asked Steven if it tasted sweet like he told Witness 1. Steven said it did not, it actually tasted like dirt. Steven admitted his tongue was in contact with Tolula's vagina for 5 seconds when this occurred. Steven said the messages that he sent to Witness 1 on 2/7/2024 8:44:11 PM(UTC-6) correlated to when this incident occurred. Steven confirmed this occurred at his residence at New Cassel Street and likely in the living room.

Lt. Lichtensteiger asked Steven to talk about the first act with his dog that he told Witness 1 about, which he indicated was some time ago. Steven said in this incident he tried to engage in intercourse with his dog. Steven said it was several years ago but did occur at his residence at New Cassel Street in Campbellsport. Steven said he did not recall many details as to when the incident occurred. Steven said it was with his eldest dog Tolula. Steven said Tolula was a dog that he and his wife purchased together when they first got together. Steven said he tried to penetrate Tolula, but was not entirely successful. Steven said he attempted to penetrate Tolula's vagina with his erect penis, but it "did not work." Steven said he was only able to fit the head of his penis into Tolula's vagina.

Steven said he was not able to get his penis further into her vagina as it did not seem to fit. Steven said he did not know why, but figured it was because they were a different species. Steven said this occurred in their bedroom while he was home alone. Steven said Tolula is a very docile dog and he did not need to use any type of drugs or sedatives for her to just lie there. Steven said Tolula was positioned on her back lying on the bed with her legs spread. Steven said he did not try to insert anything else and only used his penis into Tolula's vagina. Steven admitted he was not fully erect, but he was aroused by what he was doing.

Steven said he used lubricant on his penis to make it easier to get into Tolula, but that did not seem to help. Steven said Tolula did not really react, but rather just laid there. Steven said he was not sure if Tolula enjoyed the interaction or was aroused as a result. Steven said he did ejaculate but not inside of Tolula, but rather onto a towel. Steven said he could not recall any other details of this interaction as it was so long ago.

Steven was asked if there were other times that he engaged in any other sexual acts with Tolula or the other dogs. Steven said he believed there may have been one other time that he engaged in sexual intercourse with Tolula. Steven said he recalled the specifics to be the same. Steven said again did not know exactly when it happened. Steven said it was at his residence on New Cassel Street and again in the bedroom. Steven said wanted to try having sex with Tolula again and see if it would work this time. Steven said he was not sure how erect his penis was but recalled using lubricant. Steven said again only the head of his penis penetrated Tolula's vagina. Steven said this again was for sexual gratification.

Steven said he has not engaged in sex acts with any of the other dogs. Steven said he could only recall the three incidents described above. Steven said he has watched pornography involving humans and dogs on many occasions, both women and men engaging in sex acts with dogs.

Based on the foregoing, the complainant believes this complaint to be true and correct.
