CRIMINAL COMPLAINT

The undersigned of the Sheboygan Police Department being first duly sworn on oath deposes and says on information and belief:

Count 1: 2ND DEGREE SEXUAL ASSAULT OF A CHILD UNDER 16 YEARS OF AGE

The above-named defendant in August of 2008 or August of 2009, in the City of Sheboygan, Sheboygan County, Wisconsin, did have sexual intercourse with a child under the age of sixteen, Victim 1, DOB 09/02/1993, contrary to sec. 948.02(2), 939.50(3)(c) Wis. Stats.

Upon conviction for this offense, a Class C Felony, the defendant may be fined not more than One Hundred Thousand Dollars (\$100,000), or imprisoned not more than forty (40) years, or both.

The basis of complainant's charge of such offense is: Official reports prepared by Detective Brandon Kehoe of the Sheboygan Police Department, which reports indicate that on September 11, 2024, Detective Kehoe was assigned to a prior child sexual assault that occurred in Sheboygan Falls, County of Sheboygan, State of Wisconsin. The sexual assault occurred in either August of 2008 or 2009.

Detective Kehoe made contact with Victim 1, DOB 09/02/1993. Victim 1 reported that when he was 13 or 14, he lived a few doors down from the above-named Defendant, John Albright, DOB 09/16/1979, in the City of Sheboygan Falls, County of Sheboygan, State of Wisconsin. Victim 1 reported that in August of 2008 or 2009, The Defendant hosted a party at the end of summer. Victim 1 reported he had helped babysit the Defendant's daughter for a little while before being escorted back to the party by the Defendant.

During the walk, the Defendant started to ask him questions about puberty. Victim 1 remembers the Defendant asking him if he had grown pubic hair yet. Victim 1 told the Defendant yes and then the Defendant asked if Victim 1 knew how to shave. Victim 1 told the Defendant no. The Defendant then put his hand down Victim 1's pants to feel and said, "that's just peach fuzz."

Victim 1 reported the Defendant could tell he was uncomfortable. They continued to walk. Victim 1 reported being on Jackson Street, Oak Street, Adams Street then into the alley of Michigan Street, all being located in Sheboygan Falls, County of Sheboygan, State of Wisconsin.

While in the alley of Michigan Street, the Defendant got down on his knees, pulled the Defendant's pants down, and put his mouth on Victim 1's penis. Victim 1 reported that the Defendant performed oral sex on Victim 1's penis in a back-and-forth motion with the Defendant's mouth 3 times. Victim 1 reported he did not ejaculate. Victim 1 explained that it stopped when Victim 1 pulled up his pants and took his cellphone out. Victim 1 told the Defendant that Victim 1's sister was trying to get ahold of him. Victim 1 stated the Defendant told him the Defendant thought he was gay. The Defendant stated it was a misunderstanding. Victim 1 reported the Defendant seemed kind of panicked afterwards. Victim 1 reported the Defendant seemed buzzed from alcohol consumption.

Victim 1 reported he has had casual conversation with the Defendant since this occurred. The Defendant told him he was a very good-looking person and had invited him to be in the defendant's hot tub.
