The undersigned, of the Waukesha County District Attorney's Office being first duly sworn on oath, upon information and belief, states that:

Count 1: CHILD ENTICEMENT

The above-named defendant on or about Sunday, March 24, 2024, in the Village of Wales, Waukesha County, Wisconsin, with intent to expose a sex organ to a child, did cause a child under the age of 18, Victim A, to go into a vehicle, contrary to sec. 948.07(3), 939.50(3)(d) Wis. Stats., a Class D Felony, and upon conviction may be fined not more than One Hundred Thousand Dollars (\$100,000), or imprisoned not more than twenty five (25) years, or both.

Count 2: SEXUAL INTERCOURSE WITH A CHILD

The above-named defendant on or about Sunday, March 24, 2024, in the Village of Wales, Waukesha County, Wisconsin, did have sexual intercourse with a child, Victim A, who was not his spouse and who had attained the age of 16 years, and the actor had attained the age of 19 years, contrary to sec. 948.09, 939.51(3)(a) Wis. Stats., a Class A Misdemeanor, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than nine (9) months, or both.

Count 3: SEXUAL INTERCOURSE WITH A CHILD

The above-named defendant on or about Sunday, May 5, 2024, in the Village of Wales. Waukesha County, Wisconsin, did have sexual intercourse with a child, Victim A, who was not his spouse and who had attained the age of 16 years, and the actor had attained the age of 19 years, contrary to sec. 948.09, 939.51(3)(a) Wis. Stats., a Class A

Misdemeanor, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than nine (9) months, or both.

Count 4: SEXUAL INTERCOURSE WITH A CHILD

The above-named defendant on or about Sunday, May 19, 2024, in the Village of Wales, Waukesha County, Wisconsin, did have sexual intercourse with a child, Victim A, who was not his spouse and who had attained the age of 16 years, and the actor had attained the age of 19 years, contrary to sec. 948.09, 939.51(3)(a) Wis. Stats., a Class A Misdemeanor, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than nine (9) months, or both.

PROBABLE CAUSE:

And prays that the defendant be dealt with according to law; that the basis for complainant's charge of such offense is: Based on the investigative reports of Detective La Fleur of the Waukesha County Sheriff's Department.

On November 20, 2024, Detective La Fleur and Detective Wacker made contact with Victim A, a 16-year-old juvenile at the time of the interview. Victim A reported that he had communicated with an adult male via an app called "Sniffies" between February and March of 2024. Victim A also advised that he communicated with this same adult male on Snapchat and Telegram. Detective La Fleur reports Victim A described the adult male as a married, Lutheran school teacher with a young son. Detective La Fleur reports she later identified this adult male as Justin P. Liepert (DOB: 07/04/1989), hereinafter the defendant. Victim A advised that he met the defendant about three or four times between February and March of 2024.

Detective La Fleur reports Victim A provided her with an account name for the defendant's Snapchat account. Detective La Fleur reports a records request revealed that the IP address associated with the Snapchat account belonged to the defendant, Detective La Fleur searched the defendant's information and discovered that he is a teacher at a Lutheran school. Detective La Fleur reports a review of Victim A's snapchat records from an unrelated incident reveal Victim A asking this same Snapchat user if students at his school say odd things related to being a "hot teacher." Detective La Fleur reports the records showed the other user responding with "sometimes," and the records showed the user explaining that he teaches 9-12 grade at a private school. Detective La Fleur reports a review of the defendant's Snapchat records shows the defendant's receipt of several sexually explicit videos involving prepubescent individuals from Victim A.

Detective La Fleur reports Victim A advised that he first met the defendant after the defendant had been working late on a theater production at school. Victim A advised that the defendant had messaged him and asked if he wanted the defendant to come over. Victim A advised that the defendant showed up at his residence in the Village of Wales, Waukesha County, Wisconsin. Victim A advised that the defendant parked his vehicle at the end of the road where they engaged in anal sex before Victim A performed oral sex on the defendant. Detective La Fleur reports Victim A could not remember the specifics of their second encounter, but for the third encounter, Victim A advised that he and the defendant met outside of his residence again. Victim A advised that the defendant performed anal sex on him before Victim A performed oral sex on the defendant. Victim A advised that the fourth encounter occurred on a

nearby road to his residence. Victim A advised that the defendant wanted him to perform anal sex on him, but Victim A advised that he did not want to do it. Detective La Fleur reports Victim A advised that all of the sexual acts occurred in the middle seat of the defendant's vehicle.

Detective La Fleur reports Victim A advised that the defendant sent him a video on Telegram containing a video of the defendant engaged in anal sex with a younger male. Victim A advised that he believed the younger male to be 16 years old. Victim A also advised that the defendant admitted to having thoughts of touching his young son but this had not occurred yet.

Detective La Fleur reports she interviewed the defendant on February 13, 2025. Detective La Fleur reports the defendant advised that he has a Snapchat and Sniffies account. The defendant described Sniffies as a "gay hook-up" app. The defendant advised that he did not have his Sniffies account because he deleted it a few weeks prior. Detective La Fleur reports the defendant provided an email address associated with the Sniffies account, and Detective La Fleur observed that this email address matched the email address provided for the Snapchat account that had been communicating with Victim A. Detective La Fleur reports the defendant advised that he had this account for a year, possibly around early March 2024.

Detective La Fleur reports a forensic download of the defendant's phone revealed that the defendant's map application reported the defendant visiting Victim A's residence on March 24, May 5, and May 19, of 2024.

Based on the foregoing, the complainant believes this complaint to be true and correct.
